## Downhill-Karts – User rules

### 1.) Confirmation of the acknowledgment of the user rules by participation

Before use of the downhill carts every participant has to take note of the user rules and regulations. When using the karts the user accepts the rules and must adhere to them at all times.

### 2.) Sole Responsibility

The use of the Downhill Karts is not without risks. The Car is powered by gravity. The driver has at all times control over the speed, as well as the ability to safely stop. **The participant must at the beginning of the downhill course; make several tests with both brakes to familiarise themselves with the karts braking system in relation to the course. The participant is responsible for selfcaused accidents.** In the event of an accident caused by other participants those responsible will be liable under contributory negligence. For the liability of the Firm FREIZEIT- und SPORT-ZENTRUM MEHLISKOPF GmbH & Co. KG refer to section 5.

### 3.) Age and physical restrictions

All participants must be at least 16 years of age and be over 1.60m tall.

The user must also be in a healthy condition, both in body and mind. Users with mental or physical conditions, those who could be a danger to themselves and/or others may not use the karts.

### 4.) Safety Instructions

Every participant must have their feet in the footrests and their hands on the handle bars and brake levers. A mass start is forbidden. Drivers must not leave the downhill track or the lift track. The abandonment of the Bullcarts on the downhill track is also not allowed. Drivers are not allowed to wait at the start and must immediately begin their drive. The brake disks and connections may not be touched. Deliberate colliding is forbidden. A helmet must be worn at all times.

All instructions of the organiser are binding and must be followed at all times. Failure to follow the rules by the participant may result in the termination of their use of the downhill carts. In the case of intentional or grossly negligent violation or breach of the security requirements or instructions of the organizer, the Participants hereby accepts the responsibility for any occurring damages. The consumption of alcohol before or during participation is strictly forbidden

**5.) Liability limitation**

The Company FREIZEIT- und SPORT-ZENTRUM MEHLISKOPF GmbH & Co. KG is responsible within the framework of the legal regulations for personal injury. For damage to property or pecuniary damage liability only in the case of intent, gross negligence or negligent breach of an essential contractual obligation (cardinal duty) by the company FREIZEIT- und SPORT-ZENTRUM MEHLISKOPF GmbH & Co. KG, its representatives or agents.

**6.) Exclusion of the participant, house rules, closing force majeure, non-refund ticket price**

The Company FREIZEIT- und SPORT-ZENTRUM MEHLISKOPF GmbH & Co. KG is entitled to expel persons who do not keep to the user rules, in regard to the use of the downhill carts. The firm carries out the right and is entitled to at any time close the Downhill Karts, for safety and/or technical Reasons (fire, storm, thunderstorm, etc.)
